## City of Baxter Rules & Regulations for Operating Golf Carts on City Streets:

- DRIVERS MUST BE AT LEAST 17 YEARS OF AGE
  - O DRIVER MUST HAVE A VALID DRIVER'S LICENSE
- ALL RIDERS IN THE GOLF CART MUST REMAIN SEATED AT ALL TIMES
- CHILDREN MUST BE ACCOMPANIED BY AN ADULT DRIVER
- GOLF CARTS ARE PROHIBITED FROM BEING OPERATED ON ANY PORTION OF HWY F17, EXCEPT TO CROSS SAID STREET
- GOLF CARTS ARE PROHIBITED FROM BEING OPERATED ON SIDEWALKS
- OWNER/OPERATOR UNDERSTANDS GOLF CARTS MAY BE OPERATED FROM SUNRISE TO SUNSET. DURING THE TIME OF YEAR WHEN DAYLIGHT SAVINGS TIME IS IN EFFECT
- AN ORANGE BICYCLE SAFETY FLAG ON A STAFF HOLDER MUST BE AFFIXED TO THE BACK OF THE GOLF CART AT LEAST FIVE FEET ABOVE THE SURFACE OF THE STREET. THIS FLAG MUST BE AFFIXED AT ALL TIMES WHILE OPERATING
- AN ORANGE SLOW-MOVING VEHICLE SIGN MUST BE AFFIXED TO THE BACK OF THE GOLF CART AT ALL TIMES WHILE OPERATING
- VALID PROOF OF LIABILITY INSURANCE ON THE CART IS REQUIRED WHILE OPERATING ON CITY STREETS
- THE CITY PERMIT STICKER MUST BE AFFIXED TO THE LEFT REAR OF THE GOLF CART AS TO BE VISIBLE TO LAW ENFORCEMENT
- THERE MUST BE OPERABLE BRAKES ON THE GOLF CART AT ALL TIMES
- ANY OTHER SAFETY EQUIPMENT WHICH MAY BE REQUIRED FOR GOLF CARTS BY CHAPTER 321 OF THE CODE OF IOWA
- OWNER/OPERATOR UNDERSTANDS IF THEY DO NOT COMPLY WITH THE ABOVE RULES, THEY MAY BE SUBJECT TO FINES FROM THE BAXTER POLICE DEPARTMENT
